


Safety Oversight Annual Report 2014

Organisational structure and procedures of Swedish Transport Agency

Civil Aviation in Sweden is the responsibility of the Ministry of Enterprise, Energy and Communications. The Swedish Transport Agency is a government agency operating under the Ministry of Enterprise, Energy and Communications. The core activities within Swedish Transport Agency are Railway, Civil Aviation, Maritime, Traffic Registry and Road Traffic. The Swedish Transport Agency is institutionally separated from the Air Navigation Service Providers.

The Swedish Transport Agency has overall responsibility for civil aviation and is responsible for the authority tasks relating to air navigation services for civil and military aviation.


The Swedish Transport Agency, organisation chart is given below.





Airspace and organisation under supervision of Swedish Transport Agency

The responsible area is Sweden FIR. Sweden FIR is surrounded by FIRs of 9 States, namely Norway FIR/UIR, Kobenhavn FIR/UIR (Denmark), Rhein UIR (Germany), Warszawa FIR/UIR (Poland), Kaliningrad FIR/UIR (Russia — non-ECAC), Vilnius FIR/UIR (Lithuania), Riga FIR/UIR (Latvia), Tallinn FIR/UIR (Estonia) and Finland FIR/UIR.



24 ANSPs and five training organisations are certified by Swedish Transport Agency, see Appendix I.

Qualified entities commissioned to conduct safety regulatory audits

No qualified entities have been appointed in Sweden.

Existing levels of resources of Swedish Transport Agency

At the beginning of 2014 five fully trained ANS inspectors and two ANS inspector trainee was working at the Air Navigation Service Section. During 2014 two new ANS inspector trainees have been employed, one in February and one in April 2014. At the end of 2014 there were seven fully trained



ANS inspectors and two ANS inspector trainees. The primary tasks are safety oversight however also other tasks are conducted.

Programme of safety regulatory audits, including information about the audits conducted and their scope

There is a permanent focus on Commission Regulation No 1035/2011, including Annexes I, II, III, IV and V, and when applicable Commission Regulation No 805/2011.

During 2014 a total of 17 audits were performed on the following ANSPs; Aviation Capacity Resources AB (ATS/MET, 1 at local ATS unit), Fyrstads Flygplats AB (CN), Hemavan Tärnaby Airport AB (ATS/MET/CN), Härjedalens kommun (ATS/MET/CN), Kristianstad Airport AB (CN), LFV (ANS, 7 audits at local ATS units), Oskarshamns Utvecklings AB (ATS/MET/CN), SAAB AB (CN, 1 at local CN site), Småland Airport AB (CN), Stockholm Skavsta Airport AB (CN) and Swedavia AB (CNS, 1 at local CN site).

Safety issues identified through the safety oversight process

At some of the performed audits in 2013 and 2014 there were findings regarding safety management system (SMS) in general and safety assurance and risk assessment in particular. The corrective actions of those findings have been followed up during 2014 with satisfactory results.

Safety directives

No safety directives were issued by Swedish Transport Agency during 2014.
