### (d) Report on arrears of contributions and of advances to the Working Capital Fund and on the implementation of Article 61\* of the IMO Convention

#### Introduction

1 This document reports on the status of Member States' contributions and of advances to the Working Capital Fund as at 31 May 2009. It also addresses the current situation with regard to the implementation of Article 61 of the IMO Convention as at the same date.

#### Summary of current position

2 The situation regarding contributions made and those due and payable (including those outstanding from previous years) by all Member States, as at 31 May 2009, is summarized below:

\* This article (previously Article 56) has been renumbered as the conditions for acceptance of resolution A.724(17) were met on 7 December 2008 when the 1991 amendments to the IMO Convention entered into force.

3 From the above table, it emerges that the total amount due to the Organization, as at 31 May 2009, amounted to £6,840,907. Details with respect to individual Member States' contributions may be found at annex 1 with a separate schedule showing the status of Council Members' contributions attached at annex 2.

4 The 76.68% of current year assessment, which had been received as at 31 May 2009, compares favourably with the collection rate at the same date of 76.50% for 2008 and adversely with the rate of 80.94% for 2007.

5 By the reporting date of 31 May 2009, of the 168 Member States and three Associate Members included in the Notice of Assessment, 97 have made full payment of their 2009 assessment, 28 have made partial payment and 46 have made no payment. Comparative figures for the past two years are given below:

6 Of the 40 Council Members, 32 had made full payment of their 2009 assessment; five had made partial payments; and three had made no payment as at 31 May 2009.

#### **Application of Article 61 of the IMO Convention – 25th regular session of the Assembly**

7 Since the issuance of document C 102/5(d)/Add.1, of the 10 remaining Member States, excluding the former Socialist Federal Republic of Yugoslavia, which were not granted a waiver and consequently lost their voting rights, there have been no additional payments.

8 Of the 18 remaining Members, reported in document C 102/5(d)/Add.1, which fell under the provision of Article 61 since the twenty-fifth regular session of the Assembly, as at 1 January 2009, the Republic of the Sudan and the Democratic Republic of Timor-Leste cleared their arrears in full for 2008. Consequently, they no longer fall under the provision of Article 61. The Republic of Cameroon made a partial payment for 2008. However, the Republic of Cameroon remains under the provision of Article 61 as the assessment for 2008 remains outstanding. No additional payments were received from the remaining 15 Members.

9 There has been no further update from the United Nations Secretariat regarding the pre-dissolution arrears of the former Yugoslavia since the issuance of document C 102/5(d)/Add.1.

10 The position of each Member State, as at 31 May 2009, by reference to their status under the terms of Article 61, is shown at annex 1.

### **Advances to the Working Capital Fund**

11 There has been no change to the balance of the Working Capital Fund since the issuance of document C 102/5(d).

### **Action requested of the Council**

12 The Council is invited to:

- .1 take note of the information contained in this document;
- .2 reiterate its firm stance on the strict enforcement of Article 61 of the IMO Convention; and
- .3 decide as appropriate.
