GENERAL

The 102nd session of the Council was held from 29 June to 3 July 2009, under the Chairmanship of Mr. J. Franson (Sweden). The Vice-Chairman, Mr. D. Ntuli (South Africa), was also present.

INVITATION TO NON-MEMBERS OF THE COUNCIL TO ATTEND THE SESSION

At their request, delegations from Algeria, Angola, Antigua and Barbuda, Bahrain, Barbados, Belgium, Belize, Bolivia, Bulgaria, Colombia, the Cook Islands, Costa Rica, Côte d'Ivoire, Cuba, the Democratic People's Republic of Korea, the Dominican Republic, Ecuador, Estonia, Finland, the Gambia, Ghana, Grenada, Honduras, the Islamic Republic of Iran, Ireland, Liberia, the Libyan Arab Jamahiriya, the Marshall Islands, Mauritania, Monaco, Morocco, Peru, Poland, Saint Vincent and the Grenadines, Senegal, the Syrian Arab Republic, Tonga, Ukraine, the United Arab Emirates, Uruguay, Vanuatu and the Bolivarian Republic of Venezuela attended the session as observers. Hong Kong, China (Associate Member) also attended the session as an observer.

1 ADOPTION OF THE AGENDA (agenda item 1)

1.1 The Council adopted the agenda and proposed timetable contained in document C 102/1/Rev.1; and noted the annotations to the agenda contained in document C 102/1/1.

1.2 With respect to agenda item 18(d) (Relations with non-governmental organizations), the Council convened a group composed of representatives from the delegations of Brazil, Canada, Germany, Malaysia, the Republic of Korea, Saudi Arabia and South Africa, and open to other interested Council Members and observer delegations, to consider applications for consultative status submitted by the Bureau International des Containers et du Transport Intermodal (BIC), the Green Ship Recycling Association (GSRA), the Inflatable Safety and Survival Equipment Technical Association Limited (ISSETA), the Regional Clean Sea Organization (RECSO), the International Dangerous Goods and Containers Association (IDGCA), the Nautical Institute (NI), the Certification Association "Russian Register" and the Superyacht Builders Association (SYBAss). The group, under the chairmanship of Captain Raja Malik (Malaysia), was also requested to carry out a preliminary review of the list of non-governmental organizations in consultative status with IMO and report to the Council, as appropriate, pending the latter's advice to the twenty-sixth regular session of the Assembly. The Council expressed appreciation to Rear Admiral (ICG) G. Olimbo (Italy) for his services as chairman of the group over the previous three years.

2 REPORT OF THE SECRETARY-GENERAL ON CREDENTIALS (agenda item 2)

2.1 With reference to rule 9 of its Rules of Procedure, the Council noted the Secretary-General's report that the credentials of delegations attending the session were found to be in order.

3 STRATEGY AND PLANNING (agenda item 3)

(a) Monitoring of performance (agenda item 3(a))

3(a).1 The Council noted the information set out in document C 102/3(a), as well as that provided orally by the Chairman of the *Ad Hoc* Council Working Group on the Organization's Strategic Plan and the Secretary-General, on the outcome of the Working Group's ninth session (27 to 29 April 2009).

3(a).2 In particular, the Council:

- (i) approved, in principle, the draft Assembly resolution and draft guidelines on the application of the Strategic Plan and High-level Action Plan, set out at annex 1 to document C 102/3(a), with the request that the Working Group re-visit the draft texts, at its tenth session, with a view to accommodating, as appropriate, the matters raised also by the Maritime Safety Committee at its eighty-sixth session, including that raised by the delegation of Cyprus regarding the role of the Committees, as detailed in the IMO Convention, with respect to functions conferred upon the Organization by, or under, international conventions;
- (ii) noted the Working Group's views on the need for a "migration plan", and its intention to elaborate same at its tenth session, in order to support an effective transition from current arrangements to full implementation of the aforementioned guidelines throughout the Organization;
- (iii) requested the Working Group to submit any proposed changes to the aforementioned draft resolution and draft guidelines, together with its proposed "migration plan", to the Council, at its twenty-fifth extraordinary session, for consideration, approval and, where appropriate, submission to the twenty-sixth regular session of the Assembly for adoption;
- (iv) approved the Working Group's recommendations on identified options for a long-term strategy for the reduction of costs of international meetings as set out in table 1 of annex 2 to document C 102/3(a);
- (v) noted the Working Group's conclusion in response to the request of the United Nations General Assembly in resolution 63/232; and
- (vi) approved the report in general.

3(a).3 The Council thanked the Working Group's Chairman, Mr. D. Ntuli (South Africa); the Coordinator of the Correspondence Group, Mr. K. Poldermann (Netherlands); the members of the Correspondence and Working Groups; and the Secretariat, for the satisfactory outcome of the Group's ninth session.

(b) Risk management (agenda item 3(b))

3(b).1 The Council noted the information set out in document C 102/3(b), as well as that provided orally by the Chairman of the Council Risk Review, Management and Reporting Working Group and the Secretary-General, on the outcome of the Working Group's fourth session (30 April and 1 May 2009).

3(b).2 In particular, the Council:

- (i) approved the risk management Context Document in annex 1 to document C 102/3(b) and decided to transmit it to the twenty-sixth session of the Assembly, for endorsement;
- (ii) noted the Working Group's consideration of the report on the Secretariat's risk management exercise 2009 and, in this regard, invited the Secretary-General to make adequate provision of resources to support the delivery of future iterations of the risk management process;
- (iii) noted the risks to the Organization highlighted by the Working Group, based on the Secretariat report, and endorsed the Working Group's associated recommendations;
- (iv) endorsed the Working Group's recommendation that, before any substantive changes are made to the Risk Management Framework, the Secretariat should undertake a second iteration of the risk management process, the scope of which should cover the Strategic Directions and High-level Actions falling under the Secretary-General's responsibility, as well as the Secretariat's related key objectives for the 2010-2011 biennium;
- (v) endorsed the re-establishment of the Working Group's Correspondence Group, with terms of reference as proposed in annex 2 to document C 102/3(b); and
- (vi) approved the report in general.

3(b).3 The Council thanked the Working Group's Chairman, Mr. D. Ntuli (South Africa), the members of the Working Group and the Secretariat, for their work and the satisfactory outcome of the Group's fourth session.

4 ORGANIZATIONAL REFORMS (agenda item 4)

4.1 The Council noted the information set out in documents C 102/4 and C 102/4/1, as well as that provided orally by the Secretary-General, on organizational reforms.

4.2 With regard to document C 102/4 (reporting on progress made with the implementation of recommendations in the Joint Inspection Unit (JIU) on the Review of Management and Administration in IMO (JIU/REP/2007/7); and follow-up action taken in response to the review undertaken by the United Nations International Computing Centre (UNICC) of the Organization's Information and Communication Technology (ICT)), the Council noted the response to the recommendations made by both the JIU and UNICC.

4.3 With regard to document C 102/4/1 (reporting on developments with respect to the implementation of the International Public Sector Accounting Standards (IPSAS) and the project to update the Organization's SAP system, as well as its functionality, to include both human resources (HR) and payroll functions), the Council:

- (i) noted the information provided on progress made towards the introduction of IPSAS in the Organization;
- (ii) approved the Organization's revised Financial Regulations, as amended, to take effect from 1 January 2010, together with the associated draft Assembly resolution; and decided to forward them to the twenty-sixth regular session of the Assembly for adoption; and
- (iii) noted the information provided on progress on the project to upgrade the Organization's SAP system and implement SAP HR and payroll, noting, in particular, the future outsourcing of hosting and support of the system and the consequent changes in the scope of the project and the consequent budgetary impact.

5 RESOURCE MANAGEMENT (agenda item 5)

(a) Personnel matters, including amendments to the Staff Regulations and Staff Rules (agenda item 5(a))

5(a).1 The Council noted the information set out in the documentation, as well as that provided orally by the Secretary-General, on personnel matters, including amendments to the Staff Regulations and Staff Rules.

5(a).2 The Council also noted the information contained in document C 102/5(a), reporting on the implementation, by the Organization, of the decisions of the United Nations General Assembly with respect to the recommendations contained in the 2008 report of the International Civil Service Commission.

5(a).3 With regard to document C 102/5(a)/1, reporting on amendments to the Staff Rules, the Council noted the information set out therein, as well as information provided orally by the Secretary-General with respect to the Organization's policies on recruitment and promotions.

5(a).4 With regard to document C 102/5(a)/2, the Council noted the information on a new system of administration of justice in the United Nations and its implications for IMO, and endorsed the Secretary-General's recommendation that Option (b), which maintains a single-tier judicial review system, in line with the system of administration of justice currently applied in IMO, be adopted.

5(a).5 The Council further noted the information contained in document C 102/5(a)/3 and its corrigendum, reporting on the recruitment of women; the geographical and age distribution of staff; and staff development and training.

(b) Accounts and audit: accounts for the first calendar year of the twenty-fifth financial period and transfers within the 2008 budget (agenda item 5(b))

5(b).1 The Council noted the information set out in documents C 102/5(b) and C 102/5(b)/1, as well as that provided orally by the Secretary-General and the representative of the External Auditor, the Comptroller and Auditor General of India, on the final accounts for 2008.

5(b).2 In particular, the Council:

- (i) noted the Secretary-General's financial report and accounts for 2008;
- (ii) welcomed the unqualified opinion of the External Auditor;
- (iii) noted the excess of income over expenditure for 2008 of £1,841,753 before prior year savings and transfers;
- (iv) welcomed, with appreciation, the achievement of a Members' contribution level of 98.02%;
- (v) expressed its appreciation to the External Auditor for his report;
- (vi) welcomed the Secretary-General's stewardship of the Organization's Funds and his report to the Council;
- (vii) approved the year-end transfers between Major Programmes, in accordance with financial regulation 4.4 of the Organization's Financial Regulations and Financial Rules;
- (viii) decided to forward the financial statements, schedules, Notes to the Accounts and the External Auditor's report to the twenty-sixth regular session of the Assembly;
- (ix) noted the information provided on the accumulated liability from the operation of the Organization's Contributions Incentive Scheme; and
- (x) noted the information provided on the anticipated refund of the amount paid to the host Government under the Climate Change Levy.

(c) Report on investments (agenda item 5(c))

5(c).1 The Council noted the information set out in document C 102/5(c), as well as that provided orally by the Secretary-General, on the investment of the Organization's monies during 2008.

(d) Report on arrears of contributions and of advances to the Working Capital Fund and on the implementation of Article 61 of the IMO Convention (agenda item 5(d))

5(d).1 The Council noted the information set out in document C 102/5(d) and its addenda, as well as that provided orally by the Secretary-General, on the status of Member States' contributions, advances to the Working Capital Fund and the implementation of Article 61 of the IMO Convention.

5(d).2 In particular, the Council:

- (i) noted the improvement in the collection rate of Members' contributions compared with the same period in 2008 and the continuing arrears of the Member States identified in the documents under review;
- (ii) noted the reported developments in advances to the Working Capital Fund;
- (iii) noted, in the context of the calculation of the annual assessment, the importance of ensuring that fleet statistics are up to date on the 30 June reference date; and requested the Secretary-General to advise Lloyd's Register-Fairplay of the need to validate its relevant data before providing information to the Organization;
- (iv) urged Member States with outstanding contributions to remit them as soon as possible; and
- (v) reiterated its firm stance on the strict enforcement of Article 61 of the IMO Convention.

(e) Budget considerations for 2009 (agenda item 5(e))

5(e).1 The Council noted the information set out in document C 102/5(e), as well as that provided orally by the Secretary-General, on budget considerations for 2009.

5(e).2 In particular, the Council:

- (i) noted the forecast expenditure in the regular budget for 2009, including forecast overruns in the approved appropriation for 2009;
- (ii) endorsed the Secretary-General's decision to transfer to 2009 the unspent balance of £725,592 in the regular budget for 2008, in accordance with the Organization's Financial Regulations, to partly address the projected shortfall in the 2009 budget;

- (iii) noted that, to offset the remaining overrun not covered by the above transfer, the Secretary-General may propose, in accordance with the Financial Regulations, to the twenty-fifth extraordinary session of the Council, a supplementary budget financed from the Organization's accumulated reserves;
- (iv) authorized the Secretary-General to make, as and when necessary, timely transfers between Major Programmes to the extent that balances are available to cover or reduce deficits in programme appropriation balances, in accordance with the Organization's Financial Regulations;
- (v) noted the forecast year-end cash surplus of the General Fund;
- (vi) noted the forecast revenue and prospective overspend in the Printing Fund due to the costs for improving the publication sales environment, for which the Secretary-General may seek the Council's endorsement, at its twenty-fifth extraordinary session, of a transfer of the unused 2008 budget balance to 2009;
- (vii) approved the temporary withholding of the distribution of the balance of the 2008 expenditure budget under the Printing Fund in order that any shortfall in the 2009 Printing Fund budget can be offset by the transfer of the 2008 budgetary surplus, in accordance with the Organization's Financial Regulations;
- (viii) noted the forecast financial status of the Headquarters Capital Fund which, notwithstanding the transfer of the uncommitted 2008 budget balance approved by the Council at its 101st session, may still overrun, and that the Secretary-General may propose, in accordance with the Organization's Financial Regulations, to the twenty-fifth extraordinary session of the Council, the financing of any shortfall from the accumulated reserves of the Fund, if further cutbacks and savings are not possible; and
- (ix) noted the forecast financial status of: the Termination Benefit Fund; the Training and Development Fund; the Technical Co-operation Fund; and extra-budgetary programmes.

6 VOLUNTARY IMO MEMBER STATE AUDIT SCHEME (agenda item 6)

6.1 The Council noted the information provided in documents C 102/6 and C 102/6/1, as well as that provided orally by the Secretary-General and the delegations of the Netherlands (in document C 102/6/2) and Denmark (in document C 102/6/3), on the Voluntary IMO Member State Audit Scheme.

6.2 With regard to document C 102/6, reporting on progress made in the implementation of the Scheme, the Council:

- (i) encouraged Member States that have not yet volunteered for audits to do so as and when they are ready and as early as possible;
- (ii) invited Member States to nominate auditors to enable the Secretary-General to select audit teams from among them to conduct the audit of volunteering Member States; and

- (iii) invited Member States to nominate qualified auditors to participate in the regional training courses convened by the Organization, in order to ensure uniform training for the effective implementation of the Scheme.

6.3 The Council noted:

- (i) the ongoing training of auditors, through the ITCP, on the Audit Scheme;
- (ii) the progress made in the conduct of audits and the anticipated delivery of audits scheduled for the rest of the year;
- (iii) the issuance by the Secretariat of audit summary reports; and that the next consolidated audit summary report would be issued as a document to the twenty-sixth regular session of the Assembly; and
- (iv) the assistance provided so far under the ITCP to assist in the conduct of audits and the participation of observer auditors.

6.4 The Council encouraged Member States requiring assistance to participate in the Audit Scheme, to seek it within the framework of the ITCP, as may be applicable, and noted documents C 102/6/2 and C 102/6/3, introduced, respectively, by the Netherlands and Denmark, providing information on the experiences of those two States with regard to the Audit Scheme.

6.5 With regard to document C 102/6/1, containing the Secretary-General's analysis, as requested by the 101st session of the Council, for the further development of the Audit Scheme, the Council:

- (i) agreed to a phased-in introduction of the Organization's Audit Scheme through institutionalization;
- (ii) consented, in principle, that such an institutionalization should proceed through the introduction of appropriate requirements in the relevant mandatory IMO instruments;
- (iii) approved, in principle, the time frame and schedule of activities outlined in table 3 of document C 102/6/1, as amended to delete references to the FSI Sub-Committee;
- (iv) requested the Secretary-General to prepare a draft Assembly resolution delineating the way forward, together with a proposed time frame and schedule for the further development of the Scheme, for consideration and approval by the twenty-fifth extraordinary session of the Council, for submission to the twenty-sixth regular session of the Assembly for adoption;
- (v) welcomed the Netherlands' offer of technical assistance through the sharing of its knowledge, expertise and experiences with Member States that have volunteered and those considering to volunteer for audit, as well as its offer of financial assistance to those Member States that, owing to plausible financial constraints, are presently not prepared to volunteer for audit; and

- (vi) welcomed the offers of assistance from Italy and Egypt regarding the use of training facilities, for the purposes of the Scheme, which could be provided, respectively, by the International Maritime Safety, Security and Environment Academy (IMSSEA) in Genoa; and the Arab Academy for Science, Technology and Maritime Transport (AASTMT) in Cairo.

7 TECHNICAL CO-OPERATION FUND – BIENNIAL ALLOCATION TO SUPPORT THE ITCP PROGRAMME FOR 2010-2011 (agenda item 7)

7.1 The Council noted the information set out in document C 102/7, as well as that provided orally by the Secretary-General, on the biennial allocation from the Technical Co-operation (TC) Fund to support the delivery of the Integrated Technical Co-operation Programme (ITCP) during 2010 and 2011.

7.2 In particular, the Council:

- (i) endorsed the proposals contained in document TC 59/5 and its Corrigendum, taking into account the views and recommendations of the fifty-ninth session of the Technical Co-operation Committee;
- (ii) approved the use of the TC Fund for the proposed activities under the ITCP for 2010-2011; and the biennial allocation of US\$14 million from the TC Fund for that purpose; and
- (iii) authorized the Secretary-General to use the un-programmed funds of the TC Fund, during the next biennium, should demands or partnership opportunities arise.

8 RESULTS-BASED BUDGET FOR THE TWENTY-SIXTH FINANCIAL PERIOD 2010-2011 (agenda item 8)

8.1 The Council noted the information set out in documents C 102/8, its addendum and C 102/8/1 (Bahamas), as well as that provided orally by the Secretary-General, on the proposed results-based budget for the twenty-sixth financial period 2010-2011.

8.2 The Council expressed appreciation to the Secretary-General and his staff for the clear, transparent and thorough fashion in which the document had been presented, which had aimed at aligning the Organization's first results-based budget with its existing Strategic and High-level Action Plans; and commended the Secretary-General for presenting proposals which, under the circumstances imposed by the global financial crisis, had recognized the need for prudence, and for his efforts to secure efficiencies and economies in operation to respond to prevailing conditions.

8.3 The Council, while generally endorsing the proposed approach and structure of the results-based budget, as presented in document C 102/8, requested the Secretary-General to undertake a review of his budget proposals, taking into account comments and proposals made by Council Members and observer delegations, as well as any recommendations that may emerge from the September session of the *Ad Hoc* Council Working Group on the

Organization's Strategic Plan, in order to identify any further areas for making economies and efficiency gains, without, however, hampering the delivery of the Strategic and High-level Action Plans of the Organization. Such a revised draft budget will be presented to the Council's twenty-fifth extraordinary session for approval and submission to the twenty-sixth regular session of the Assembly for adoption.

9 CONSIDERATION OF THE REPORTS OF THE MARITIME SAFETY COMMITTEE (agenda item 9)

9.1 The Council noted the information set out in document C 102/9 and its addendum, as well as that provided orally by the Chairman of the Maritime Safety Committee and the Secretary-General, on the report of the Maritime Safety Committee's eighty-fifth (26 November to 5 December 2008) and eighty-sixth (27 May to 5 June 2009) sessions.

- (iv) the decision of the Committee to initiate a comprehensive revision of the FAL Convention with a view to ensuring that it adequately addresses the present and emerging needs of the shipping industry as well as for modernization of its provisions taking into account recent relevant developments;
- (v) the progress made in relation to the development of an explanatory manual to the FAL Convention;
- (vi) the progress made in relation to the transmission, by electronic means, of information relating to the clearance of ships; and on the revision of the IMO Compendium on facilitation and electronic business;
- (vii) that the Committee had requested the Secretariat to continue the IMO Stowaway Focal Point trial period;
- (viii) the decisions of the Committee concerning the scope of issues to be considered in connection with the disembarking of persons rescued at sea and the issue of a relevant FAL.3 circular on administrative procedures;
- (ix) the action taken in relation to denial of IMDG Code class 7 radioactive materials, including those in packaged form used in medical or public health applications;
- (x) that the Committee had requested the Secretariat to continue the trial mechanism for the resolution of difficulties in the carriage of IMDG Code class 7 radioactive materials;
- (xi) the action taken by the Committee on issues relating to delivery of technical assistance in the field of facilitation of international maritime traffic;
- (xii) the thematic priorities for the facilitation of international maritime traffic, which have been proposed for inclusion in the ITCP for the 2010-2011 biennium;
- (xiii) the adoption of amendments to the Committee's Guidelines on organization and method of work to harmonize them as much as possible with those of the MSC and MEPC;

- (xiv) the draft resolution on Revision of the Guidelines on the allocation of responsibilities to seek the successful resolution of stowaway cases (resolution A.871(20)), to the twenty-sixth regular session of the Assembly, for consideration with a view to adoption;
- (xv) the recommendation that two meeting weeks should be allocated for sessions of the Committee during the 2010-2011 biennium; and
- (xvi) the actions taken in relation to the revision of the role, mission, strategic direction and work of the Committee and the arrangements made to ensure that they are and remain consistent with the Strategic Plan for the Organization.

10.3 The Council approved the report of the thirty-fifth session of the Facilitation Committee and decided to transmit it, together with its comments and recommendations, to the twenty-sixth regular session of the Assembly, in accordance with Article 21(b) of the IMO Convention.

- (vi) the Committee's decision not to develop, at this stage, a binding instrument on places of refuge;

- (vii) the Committee's deliberations with respect to the review of national legislation on piracy and, in particular, its encouragement to Members, which had not yet done so, to submit the legislation requested by Circular letter No.2933 of 23 December 2008; and
- (viii) the Committee's decision to amend its Rules of Procedure.

- (v) authorized the Secretary-General to perform the depositary and other functions required of him under the Final Act of the Conference and the Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009, as set forth in documents SR/CONF/45 and SR/CONF/46.

14 PROTECTION OF VITAL SHIPPING LANES (agenda item 14)

14.1 The Council noted the information set out in the documentation, as well as that provided orally by the Secretary-General, on protection of vital shipping lanes.

14.2 The Council, having also noted recent developments in the United Nations on the issue of piracy and armed robbery against ships off the coast of Somalia and, in particular, the adoption of several United Nations Security Council resolutions, especially

resolutions 1844 (2008), 1846 (2008) and 1851 (2008), expressed appreciation to the Secretary-General and staff for their efforts to contribute to activities undertaken by the United Nations and others, to stem the incidence of piracy and armed robbery off the coast of Somalia and in the Gulf of Aden.

14.3 With regard to documents C 102/14, C 102/14/1, C 102/14/3 and Corr.1 and C 102/INF.3 (reporting, respectively, on the outcome of the January 2009 Sub-regional meeting on maritime security, piracy and armed robbery against ships for Western Indian Ocean, Gulf of Aden and Red Sea States; the Project profile for the implementation of the Djibouti Code of Conduct; Piracy and armed robbery in waters off the coast of Somalia; and the Seoul High-Level Meeting on Piracy off the Coast of Somalia), the Council:

- (i) noted, with appreciation, the continuing efforts of the United Nations, IMO and the maritime community at large, to repress the incidence of piracy off the coast of Somalia and in the Gulf of Aden;
- (ii) noted, also with appreciation, the outcome of the Djibouti Meeting and, in particular, the adoption of the Djibouti Code of Conduct and associated resolutions;
- (iii) authorized the Secretary-General to perform the functions of Depository of the Record of the Djibouti Meeting;
- (iv) expressed appreciation to the Governments of those States and international organizations, which had hosted, supported and assisted the Meeting;
- (v) expressed deep appreciation to those Governments, and their navies, which have deployed warships and military aircraft to ensure that ships carrying humanitarian aid on behalf of the World Food Programme are escorted to Somali ports and are patrolling the waters off the coast of Somalia in order to protect seafarers, fishermen and passengers on board ships sailing through these waters and to ensure the uninterrupted flow of traffic through the Gulf of Aden; and encouraged them, as well as other Governments and navies, to assist in the attainment of these objectives;
- (vi) noted the proposed technical assistance activities pursuant to the Djibouti Code of Conduct;
- (vii) noted, with appreciation, the generous contribution by Japan of US\$15 million towards implementing the Djibouti Code of Conduct, as well as that of the Netherlands and Norway in support of the Organization's anti-piracy effort;
- (viii) noting the outcome of the Seoul High-Level Meeting and, in particular, the adoption of the Seoul Statement, encouraged Member States to implement fully its recommendations; and
- (ix) requested the Secretary-General to report developments to the twenty-fifth extraordinary session of the Council.

14.4 With regard to document C 102/14/2 (reporting on further progress made following the 2007 Singapore Meeting on the Straits of Malacca and Singapore: Enhancing Safety, Security and Environmental Protection, in particular in respect of the development of the Cooperative Mechanism (CM) established by the Straits' three littoral States), the Council noted

the additional information provided orally by the delegations of Malaysia, Indonesia and Singapore and:

- (i) expressed appreciation to Malaysia for hosting the recent Aids to Navigation Fund (ANF) Committee Meeting, and the littoral States of Indonesia, Malaysia and Singapore for the timely implementation of the various components of the Cooperative Mechanism on the Straits of Malacca and Singapore;
- (ii) also expressed appreciation to Member States, intergovernmental and non-governmental organizations, in particular India, the United Arab Emirates, the Nippon Foundation, MENAS and the Malacca Straits Council, for contributions made, and support pledged, to the various projects under the CM and the ANF;
- (iii) noted the progress made in the completion of an informal Joint Technical Arrangement between IMO and the littoral States on co-operation between them and the Organization on safety and environmental protection in the Straits of Malacca and Singapore; and
- (iv) invited Member States and the industry to contribute to the ANF and the *ad hoc* IMO Straits Fund.

14.5 The Council reaffirmed its mandate to the Secretary-General to continue his work relating to the protection of shipping lanes of strategic importance and significance; and to report to the Council, as and when appropriate.

(b) Joint Inspection Unit (agenda item 18(b))

18(b).1 The Council noted the information set out in document C 102/18(b) and its addendum, as well as that provided orally by the Secretary-General, on the reports of the Joint Inspection Unit (JIU) and the actions taken by the Secretary-General thereon.

18(b).2 The Council, in particular:

- (i) with regard to the report entitled “Voluntary contributions in the United Nations System Organizations – Impact on programme delivery and resource mobilization strategies” (JIU/REP/2007/1), concurred with the Secretary-General’s views and his explanation on the status of those recommendations addressed to legislative bodies contained in the report;
- (ii) with regard to the report entitled “Age Structure of Human Resources in the Organizations of the United Nations System” (JIU/REP/2007/4), concurred with recommendations 1, 2 and 5 therein, recognizing that the Secretary-General’s regular reports to the Council on human resource issues adequately address the thrust of the aforementioned recommendations; and
- (iii) endorsed, in principle, the Secretary-General’s comments on the reports and welcomed the action already taken or underway regarding the recommendations addressed to him; and noted the 2008 Annual Report of the Joint Inspection Unit and Programme of Work for 2009 – Supplement No.34 (A/63/34), annexed to document C 102/18(b)/Add.1.

(c) Relations with intergovernmental organizations (agenda item 18(c))

18(c).1 The Council noted the information set out in document C 102/18(c) and its addendum, as well as that provided orally by the Secretary-General, on relations with intergovernmental organizations.

18(c).2 The Council approved the proposed revised Agreement of Co-operation between IMO and the Organization of American States (OAS); and decided to submit it to the twenty-sixth regular session of the Assembly for final approval.

(d) Relations with non-governmental organizations (agenda item 18(d))

18(d).1 The Council noted the information set out in the documentation, as well as that provided orally by the Secretary-General and the Chairman of the Group of Council Members, on relations with non-governmental organizations.

18(d).2 With regard to new applications for consultative status, the Council decided:

- (i) to refer the application of the Bureau International des Containers et du Transport Intermodal (BIC) for further screening by the MSC and the FAL Committee;
- (ii) not to grant consultative status to the Green Ship Recycling Association (GSRA);
- (iii) not to grant consultative status to the Inflatable Safety and Survival Equipment Technical Association Limited (ISSETA);
- (iv) not to grant consultative status to the Regional Clean Sea Organization (RECSO);
- (v) not to grant consultative status to the International Dangerous Goods and Containers Association (IDGCA);
- (vi) to grant consultative status to the Nautical Institute (NI);
- (vii) not to grant consultative status to the Certification Association “Russian Register”; and
- (viii) to refer the application of the Superyacht Builders Association (SYBAss) for further screening by the MSC.

18(d).3 With regard to applications previously considered by the Council, the Council decided:

- (i) to grant consultative status to the Hot Briquetted Iron Association (HBIA) on a provisional basis, for no more than two years, after which a review should be conducted;
- (ii) not to grant consultative status to MYBA;
- (iii) to grant consultative status to the World Shipping Council (WSC);
- (iv) to grant consultative status to NACE International; and
- (v) to grant consultative status to the International Association of Airport and Seaport Police (IAASP).

18(d).4 The Council noted that the IUCN had reverted to its original name, i.e. the International Union for Conservation of Nature, retaining the acronym IUCN.

18(d).5 With regard to its review of organizations in consultative status (document C 102/18(d)/1), the Council decided:

as concerns organizations in consultative status on a provisional basis:

- (i) to convert the consultative status granted to the International Fund for Animal Welfare (IFAW) on a provisional basis to full consultative status; and
- (ii) to retain the provisional consultative status of the International Spill Control Organization (ISCO) for an additional two years;

as concerns the list of the remaining non-governmental organizations in consultative status:

- (iii) to remind the International Council of Marine Industries Associations (ICOMIA) and the International Navigation Association (PIANC) of the necessity to fulfil their obligations in accordance with the Rules Governing Relationship with Non-Governmental International Organizations and the Guidelines on the Grant of Consultative Status and that, should there be no improvement in their performance, their status may be withdrawn; and
- (iv) to express strong concern over any activities, which are incompatible with the conditions under which non-governmental organizations have been granted consultative status; and to request that Friends of the Earth International (FOEI) and Greenpeace International refrain, in the future, from acting in a manner that may shed a negative light on the Organization.

18(d).6 With regard to the remaining organizations listed in document C 102/18(d)/1, the Council decided to recommend to the Assembly, at its twenty-sixth regular session, that their consultative status be maintained.

(e) World Maritime Day 2010 (agenda item 18(e))

18(e).1 The Council noted the information provided orally by the Secretary-General on the arrangements for World Maritime Day 2010 and endorsed his proposal that the theme for the Day should be:

“2010: Year of the Seafarer”

18(e).2 The Council authorized the Secretary-General to make the necessary arrangements for the celebration of World Maritime Day 2010, in accordance with the established practice.

(f) International Maritime Prize (agenda item 18(f))

18(f).1 The Council noted the information set out in the documentation, as well as that provided orally by the Secretary-General, on the International Maritime Prize.

18(f).2 The Council decided to award the International Maritime Prize for 2008 to Engineer Alberto Alemán Zubieta and extended its congratulations to him. It also expressed its appreciation to the Government of Panama for nominating such an eminent candidate for the Prize.

18(f).3 The Council also expressed its appreciation to Mr. Jerzy W. Vonau, who also had impressive credentials, and to the Government of Poland for nominating such an eminent candidate for the Prize.

18(f).4 The Council noted and endorsed the measures taken and those proposed by the Secretary-General in respect of the 2009 Prize.

(g) IMO Award for Exceptional Bravery at Sea (agenda item 18(g))

18(g).1 The Council noted the information set out in document C 102/18(g) and its addendum, as well as that provided orally by the Secretary-General, on the IMO Award for Exceptional Bravery at Sea.

18(g).2 The Council endorsed the decision of the Panel of Judges to bestow the 2009 IMO Award for Exceptional Bravery at Sea jointly on Mr. Maurice Conti and Mrs. Sophie Conti, nominated by the Government of New Zealand, and on AST2 Abram A. Heller, nominated by the Government of the United States.

18(g).3 In addition, the Council agreed that Certificates of Commendation in recognition of meritorious services rendered should be awarded to the following nominees:

- (i) the Master and crew of the vessel **Xin Ou Zhou**, nominated by the Government of China;
- (ii) Lt. César Osvaldo Lara Basto, Officer in the Propulsion Division of the coastal patrol vessel **ARM Rayon (PC-206)**, nominated by the Government of Mexico;
- (iii) Captain Cha Sang Geun, of the M/T **STX ACE 7**, nominated by the Governments of the Republic of Korea and Viet Nam; and
- (iv) Captain Bobby Noble and Mr. Tejay England, crew members of the sunken vessel **Lynette Marie**, Canadian Coast Guard Auxiliary, nominated by the International Maritime Rescue Federation (IMRF).

18(g).4 The Council further agreed that Letters of Commendation should be sent to the following nominees:

- (i) Mr. Nabil Abdelaziz (posthumously), able seaman of the tugboat **Skikda**, nominated by the Government of Algeria;
- (ii) Lt. Cdr. Leonardo Barbosa Corrêa (2nd Pilot), Lt. (Marine Corps) Wagner Pinto Alves (1st Pilot), Lt. Junior Grade (Medical Corps) Mahmud Nayef Mahd Hasan Ihamid (Doctor) and Corporal Ângelo Cesar Suzano Rocha (Flight mechanic/Winch operator), of the AS350 Squirrel Helicopter (HU-5 Helicopter Squadron, Brazilian Navy), nominated by the Government of Brazil;
- (iii) Captain Zeng Zuoqing, of the rescue tug **Nanhaiju 101**, Nanhai Rescue Bureau, nominated by the Government of China;
- (iv) the crew of the **Hai Xun 1903**, Beihai Maritime Safety Administration, nominated by the Government of China;
- (v) seventeen Italian Coast Guard Officers and Personnel, nominated by the Government of Italy;
- (vi) Lt. Cdr. Vanessa Anne I. Garon and Ensign Maria Alexandra I. Garon, Philippine Coast Guard Auxiliary, nominated by the Government of the Philippines and IMRF;
- (vii) Captain Kim Shin Ho, of the M/V **KMTC Portkelang**, nominated by the Government of the Republic of Korea;
- (viii) Captain Jason T. Bosley, Associated Branch Pilots (American Pilots' Association), nominated by the International Maritime Pilots' Association (IMPA);
- (ix) Captain Reed Southerland and Captain Matthew Bailey, Association of Maryland Pilots (American Pilots' Association), nominated by IMPA;
- (x) Mr. Dan Schwall (Project Manager), Mr Jim Conroy (Salvage Master), Mr. Mike Wood (Salvage Engineer), Mr. Stephen Wood (Assistant Salvage Master), Mr. Terry Barrows (Salvage Foreman) and Mr. Nigel Raithby (Salvage Officer), nominated by the International Salvage Union (ISU); and
- (xi) Mr. Jun Wang, rescue swimmer of Beihai No.1 Rescue Flying Service, China Rescue and Salvage, nominated by IMRF.

18(g).5 The Council extended its congratulations to Mr. Maurice Conti and Mrs. Sophie Conti and to AST2 Abram A. Heller, the joint winners of the 2009 IMO Award for Exceptional Bravery at Sea, and to those candidates who had been selected to receive Certificates of Commendation or Letters of Commendation; and also expressed appreciation to all the remaining candidates and to those Governments and organizations, which had nominated such worthy candidates for the Award.

18(g).6 The Council endorsed the Secretary-General's proposal that a special, one-off, Certificate for Exceptional Services Rendered to Shipping and Mankind be presented to the commanding officers, officers, petty officers and crews of the naval ships that have participated in the international efforts to repress piracy off the coast of Somalia and in the Gulf of Aden.

18(g).7 The Council noted and endorsed the arrangements proposed by the Secretary-General in respect of the 2010 Award.

19 REPORT ON THE STATUS OF THE CONVENTION AND MEMBERSHIP OF THE ORGANIZATION (agenda item 19)

19.1 The Council noted the information set out in document C 102/19 and its corrigendum, as well as that provided orally by the Secretary-General, on the status of the Convention and membership of the Organization.

19.2 The Council particularly noted, with great satisfaction, the further growth in the membership of the Organization, following the action taken by the Secretary-General, in response to the request made at its 101st session, to encourage States, not yet Members of the Organization, to consider joining the membership. In this context, the Council extended a warm welcome to the Republic of Uganda, the 169th Member of the Organization; and looked forward to welcoming the Federated States of Micronesia in the Organization in due course.

19.3 The Council recommended that IMO Member States, which are not members of the International Hydrographic Organization (IHO), consider joining that Organization for the reasons explained by the Secretary-General.

20 REPORT ON THE STATUS OF CONVENTIONS AND OTHER MULTILATERAL INSTRUMENTS IN RESPECT OF WHICH THE ORGANIZATION PERFORMS FUNCTIONS (agenda item 20)

20.1 The Council noted the information set out in document C 102/20 and its addendum, as well as that provided orally by the Secretary-General, on the status of conventions and other multilateral instruments in respect of which the Organization performs depositary functions.

20.2 The Council endorsed the Secretary-General's continuing efforts to encourage Governments to consider accepting those instruments to which they were not yet Parties; and, in particular, reiterated its plea to Member Governments to pay special attention to ratifying:

- (i) as far as safety-related conventions are concerned, the 1993 Torremolinos Protocol and the 1995 STCW-F Convention; and
- (ii) as far as environment-related conventions are concerned, the 2004 Ballast Water Management Convention,

in order to enable them to enter into force as soon as possible. The Council also urged Member Governments to ratify Annex VI to the MARPOL Convention (on Prevention of air pollution from ships).

20.3 As far as security-related conventions are concerned, the Council endorsed the need for an early entry into force of the 2005 SUA Protocols and, consequently, urged Member Governments to take the necessary action to effect this, as a matter of priority.

20.4 The Council urged both Signatory and non-Signatory States to consider ratifying the 2007 Nairobi International Convention on the Removal of Wrecks; and further urged Governments to take prompt action with regard to the recently-adopted Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009, which will be open for signature at the IMO Headquarters from 1 September 2009 to 31 August 2010. The Council encouraged Governments to consider ratifying the ILO's Consolidated Maritime Labour Convention, 2006.

20.5 The Council requested the Secretary-General to continue communicating with Governments that had not yet ratified IMO treaties, encouraging and assisting them to accept and implement these treaties at their earliest convenience.

- (i) its twenty-fifth extraordinary session would be held on Thursday, 19 and Friday, 20 November 2009 at the Headquarters of the Organization; and
- (ii) its 103rd session would be held on Friday, 4 December 2009, at the Headquarters of the Organization, at the conclusion of the twenty-sixth regular session of the Assembly.

22(a).3 The Council noted the draft amendments to the Rules of Procedure of the Assembly contained in paragraphs 1 and 2 of the document, and agreed to transmit them to the twenty-sixth regular session of the Assembly, for adoption.
