(d) Report on arrears of contributions and of advances to the Working Capital Fund and on the implementation of Article 56 of the IMO Convention

Note by the Secretary-General

SUMMARY

Executive summary: This document provides an update on the status of Member States' contributions and of advances to the Working Capital Fund as at 31 May 2006; as well as on the implementation of Article 56 of the IMO Convention

Action to be taken: Paragraph 12

Related documents: C 96/3(d), C 96/3(d)/Add.1 and C 96/3(d)/Add.2

Introduction

1 This document provides an update, as at 31 May 2006, on the status of Member States' contributions and of advances to the Working Capital Fund originally provided in document C 96/3(d) and its subsequent addenda. It also addresses the current situation with regard to the implementation of Article 56 of the IMO Convention as at the same date.

Summary of current position

2 The situation regarding contributions made and those due and payable (including those outstanding from previous years) by all Member States, as at 31 May 2006, is summarized below:

3 The total amount due to the Organization, as at 31 May 2006, amounted to £8,153,664. Details with respect to individual Member States' contributions are provided at annex 1 with a separate schedule showing the status of Council Members' contributions attached at annex 2.

4 The 69.95% of current year assessments, which had been received as at 31 May 2006, compares favourably with the figures at the same date of 56.49% and 64.96% for 2004 and 2005, respectively.

5 Of the forty Council members, 28 had made full payment of their 2006 assessment; five had made partial payment; and seven had made no payment as at 31 May 2006.

Application of Article 56 of the IMO Convention – 24th regular session of the Assembly

6 The Assembly, at its twenty-fourth regular session, having considered applications for waiver of the provision of Article 56 of the IMO Convention, concerning the right to vote, in accordance with Rule 56*bis* of its Rules of Procedure, granted waivers to two Member States on reviewing the schedule of payments submitted and pledges made by them to settle their arrears. Fourteen Members were not granted a waiver and consequently lost their voting rights.

7 Both of the Members which were granted waivers (i.e., the Republic of Bolivia and the Republic of Peru) have cleared their arrears in full, in accordance with their undertaking, and partly paid for 2006 and, consequently, neither Member falls under the provisions of Article 56.

8 No payments were received during May 2006, from the other 14 Members which had lost their voting rights, as explained above.

9 Of those Members, which had fallen under Article 56 since the twenty-fourth session of Assembly, three additional payments were received since document C 96/3(d)/Add.2 was issued. The Commonwealth of Dominica, the Lebanese Republic and the Republic of Lithuania have fully cleared their arrears for 2005. These Member States thus no longer fall under the provision of Article 56. The Republic of Lithuania has also partly paid its contribution for 2006.

10 The position of each Member State, as at 31 May 2006, by reference to their current status under the terms of Article 56, is also shown at annex 1.

Advances to the Working Capital Fund

11 There have been no payments made to the Working Capital Fund since the position reported in document C 96/3(d)/Add.2.

Action requested of the Council

12 The Council is invited to take note of the information contained in this document and comment as it may deem appropriate.
