How to register

- Send this form and the required attachments (see p. 2) as a PDF-file to certifikat.w3d3@transportstyrelsen.se
- The student will then receive an invoice and an e-mail containing username and password for the theoretical examination system.

In that case, you will also not be allowed to take any more exams in any of the EASA Member States for 12 months or more.

Once registered, I will receive an invoice for a fee covering one attempt per subject. If I need to retake any exams, I will be invoiced for those exams afterwards, when the entire examination has been completed. If I cancel the theoretical examinations, the Swedish Transport Agency will only refund fees for examination attempts that I have not utilized.
