The form should be submitted together with and in the same e-mail as the application form for the privilege that has been checked (e.g. L-1648 for multi pilot aeroplane). If this is not possible, the examiner must submit this form including a clear message of which check it is referring to.

**Examiners who fulfil the requirement of checking PBN privileges are not exempted from the requirement to undergo a PBN proficiency check themselves.**
