Information on date of birth of the contact person(s) (reference person(s)) is optional, but if the information is not provided, the reference persons may not be able to access the e-service when a login is provided for foreign operators. They will then have to continue to apply by paper forms, which will prolong the application process. Authorisation for check of criminal records for aviation security

Information on who holds a criminal records check is sensitive information and should be treated restrictively. Companies, applying for records checks for aviation security, are therefore required to register the persons who shall be given authority as contact persons between the company and the Swedish Transport Agency. When authorization has been assigned, the contact person receives the role of reference person and with it comes a number of authorizations and responsibilities that the reference person must be aware of.

Authorizations

A reference person is authorized to: Apply for criminal records checks for aviation security, deregister current criminal records checks, contact the Swedish Transport Agency and ask questions about the records checks for their organisation.

REKON

Reference persons who have stated their Swedish social security number* in the authorization application, and who also holds a Swedish Bank ID, will be granted access to REKON, the Swedish Transport Agency's e-service for digital management of criminal records checks for aviation security. All handling of records checks takes place in REKON, such as the application for a criminal records check, completion of an application lacking necessary information, dispatching of decisions and certificates of approved records checks as well as deregistration of current criminal records checks.

Here you will find information about how the Transport Agency deals with personal data:

Time-limited access to REKON

For security reasons, the access to REKON is limited to 2 years. A notification by E-mail, telling that the access will soon expire, will be sent to the reference persons well in time for them to re-apply for access for another period of 2 years, if the assignment as a reference person is still relevant. In the absence of an application for extension, the access will end on the stated date in the notification.

Applying for criminal records checks by paper forms

If the reference persons do not want to provide information on their date of birth or do not have a Swedish social security number that allowes them the possibility to hold a Swedish Bank ID, they will not be able to access our e-service for criminal records checks. In these cases, they will have to continue to apply by paper forms.

Responsibilities

The reference persons are responsible for: Keeping an updated list of active criminal records checks and promptly notifying the Swedish Transport Agency when termination of a records check is due. This is of great importance to prevent records checks being carried out whithout legal basis.

The reference persons also have the responsibility to notify the Swedish Transport Agency when the assignment as a reference person ends. This so that the authorization as a reference person, as well as any access to REKON, can be removed and their personal data can be deactivated in the system.
