Instructions**Who is authorised to apply?**

An owner who is registered in the Swedish register, or the person who acquired the vessel. Note that the person who acquired the vessel cannot apply for deletion of mortgages, see also under *Deletion of mortgage*.

Filer/Contact person/Invoice recipient

The filer/contact person is the party submitting the matter to the Swedish Transport Agency. This can be a business or a person: the seller, buyer, broker or some other initiated party. State the filer's name and address as well as their contact details, so we can contact them if there are any questions.

If the invoice is not to be sent to the filer, but to another person, specify who in the *Other information* box.

If there is a separate invoicing address, and if a reference number is needed on the invoice, use the *Other information* box.

Vessel

Information about the vessel is stated here: its name, Swedish call sign and IMO number, if any.

Registered owner(s)

Information must be provided about all of the vessel's owners. If there are several owners, use the *Other information* box to state each one's name, share and address. If the space in the box is insufficient, use a *separate sheet of paper*, and make a note on the form that it has an *annex*.

Acquisition

State how the vessel was acquired: purchase, gift, inheritance etc., and on what date ownership rights were transferred to the applicant. Note that the acquisition must have been completed before the application is submitted to the Swedish Transport Agency. If the date of acquisition is in the future, the Swedish Transport Agency will be unable to process the application until the acquisition has been completed.

Deletion of mortgage

Apply to deletion of all mortgages on the vessel by ticking the box. The associated mortgage deeds must be submitted in original together with the application for deregistration.

If a mortgage lien has been granted on the ship and mortgage deeds issued, the ship may not be deregistered until the mortgage deeds are submitted, in original, for deletion. Submission of a mortgage deed in original is equivalent to consent in writing from the holder of the mortgage deed/the creditor.

Application for deletion of mortgage must be submitted together with this application, by the party for whose acquisition registration was most recently sought, in those cases where a new (foreign) owner applies for deregistration.

Certificate of Deregistration

By ticking this box you request a formal Certificate of Deregistration. Certificates of Deregistration are in some cases required by other countries' vessel registers when registering with them. Rates currently charged for this are specified in the Swedish Transport Agency's charging regulation.

Other information

Use this box to specify if there are several acquirers, or for other information that might be helpful to the processing of the case.

Signature(s)

The person or persons signing have to be authorised signatories for the applicant if the applicant is not a natural person.

Certificates of authorisation to sign for foreign businesses, Swedish and foreign associations, municipalities and government agencies need to be submitted together with the application.

In the event of signing for an estate, all beneficiaries to the estate have to sign.

Fees are charged in accordance with current rates at the time of the decision.
