Instructions

Filer/Contact person/Invoice recipient

The filer/contact person is the party submitting the matter to the Swedish Transport Agency. This can be a business or a person: the seller, buyer, broker or some other initiated party. State the filer's name and address as well as their contact details, so we can contact them if there are any questions.

If the invoice is not to be sent to the filer, but to another recipient, specify that recipient in the *Other information* box.

If there is a separate invoicing address, and if a reference number is needed on the invoice, specify these in the *Other information* box.

Information about the amount of the mortgage and the currency/unit of value

Fill in the amount of the mortgage, written out in letters as well as in numerals. Also state which currency the mortgage is to have.

Mortgage priority

If the mortgages are to apply with equal priority, state that under this heading. Alternatively, state that the mortgages are to apply with priority in the order specified in the box above.

Annotation about mortgage deed holder

State here who is/are to be the holder/s of the mortgage deeds. If different lenders are going to be holders, specify them in the *Other information* box. If the space in the box is insufficient, all the mortgage deed holders can be presented on a *separate sheet of paper*. If you do, make a note on the form that it has an *annex*. It is important to state clearly which mortgage/s each holder is to have a mortgage deed for.

Dated extract from the register

In the event of signing for an estate, all beneficiaries to the estate have to sign.
