Instructions**Filer/Contact person/Invoice recipient**

The filer/contact person is the party submitting the matter to the Swedish Transport Agency. This can be a business or a person: the owner, the charterer, broker or some other initiated party. State the filer's name and address as well as their contact details, so we can contact them if there are any questions.

State in the Other information box if the invoice is to be sent to a recipient other than the submitter. If there is a separate invoicing address, or if a reference number is needed on the invoice, specify these in the other information box.

Ship

Always state the name of the ship. If the ship has a call sign/reserved call sign and an IMO-number, also provide these details. This information is required to identify the ship.

Owner(s) and charterer

Provide information about the owner(s) and the charterer of the ship.

The application must be submitted in original to the Swedish Transport Agency. The owner(s) must have signed the application.

If the ship's owner submits the application in the capacity of a business, the authorised signatory or signatories of the business must sign the application, and proof of authority to sign on behalf of the business must be provided.

If another party, for example the charterer, signs and submits the application on behalf of the owner, a power of attorney from the ship's owner must be submitted in original. The power of attorney must demonstrate that the representative has been granted authority to apply for registration of a ship in the bareboat register.

If the representative is a business, the application must be signed by the authorised signatory or signatories of that business. Proof of authority to sign must also be provided.

Other information
