## Instructions

### Filer/Contact person/Invoice recipient

The filer/contact person is the party submitting the matter to the Swedish Transport Agency. This can be a business or a person: the owner, the charterer, broker or some other initiated party. State the filer's name and address as well as their contact details, so we can contact them if there are any questions.

State in the Other information box if the invoice is to be sent to a recipient other than the submitter. If there is a separate invoicing address, or if a reference number is needed on the invoice, specify these in the Other information box.

### Ship

Under this section, details of the ship must be provided, including the ship's name, Swedish call sign, and, if applicable, IMO number.

### Owner(s)

Information must be provided about all of the ship's owners. If there are several owners, use the Other information box to state each one's name, and address. If the space in the box is insufficient, use a separate sheet of paper, and make a note on the form that it has an annex.

### Reason for deregistration

Specify whether the ship is to be deregistered because the bareboat charter agreement has ended, or for another reason.

### Certificate of Deregistration

A document of the decision to deregister the ship is always issued in Swedish. By ticking this box you request a formal Certificate of Deregistration. Certificates of Deregistration are in some cases required by other countries' ship registers when registering with them. Rates currently charged for Certificates of Deregistration are specified in the Swedish Transport Agency's regulations (TSFS 2024:78) on fees.

### Other information

Use this box to specify if there are several acquirers, or for other information that might be helpful to the processing of the case.

### Signature(s)

The owner(s) must have signed the application. If the owner submits the application in the capacity of a business, the person(s) signing must be authorised signatories of the business, and their authority to sign must be demonstrated.

Certificates of authorisation to sign for foreign businesses, Swedish and foreign associations, municipalities and government agencies need to be submitted together with the application.
