Information

When do I need to apply for an exemption?

In the following cases, you have to apply to the Swedish Transport Agency for an exemption:

- If you wish to have a vehicle registered for use, although it does not comply with the applicable requirements
- If you cannot show that the vehicle complies with the applicable requirements.

The Swedish Transport Agency will examine whether or not there are reasons to exempt the vehicle from some of the requirements.

After the examination, you will receive a decision stating, whether or not the Swedish Transport Agency has granted an exemption. The Swedish Transport Agency will decide to grant an exemption if there are reasonable grounds to do so.

How do I apply?

Complete the application form, enclosing any relevant documents, and send it to the Swedish Transport Agency, preferably via e-mail.

The following information has to be clearly stated:

Applicant/Manufacturer

Personal data and contact details: name, address, telephone number and e-mail address. We may have to contact you, so please fill out these details accurately.

The application concerns

State the make (trade name of manufacturer) and model of the vehicle or vehicles that the application concerns. If the application concerns several vehicles, they can be stated in an enclosure to the application form. State name or company if the application is limited to a specific user of the vehicle. State the vehicle's registration number, or its vehicle identification number (VIN). Also state whether the application concerns a new vehicle or one which has been put into service. If the vehicle is not new, state the date when it was first issued. For imported cars not yet registered in Sweden, state the date when the car was first issued in the country of origin.

State the reason why your vehicle shall or may be exempted from applicable requirements. We would appreciate it if you referred to the regulations, EU directives or similar where the requirements are found. Enclose this information in separate documents if you cannot fit it into the application form.

Fees

If an examination fee is to be paid, we will come back to you with further information before we initiate the handling of the matter.
