The temporary registration can only be granted if the origin has been approved.

### **Temporary registration – import**

When you apply for a verification of origin, you should state if you intend to apply for temporary registration. The decision of whether to assign temporary registration for your vehicle or not, is taken first after the verification of origin is approved. The temporary registration is valid for three months and can be approved when the applicant, the owner of the vehicle, is a permanent resident of Sweden and have purchased the vehicle abroad. The validity cannot be extended and will be cancelled upon a change of ownership.

To apply for temporary registration, please fill in the form and send it to us along with

• a Swedish certificate of motor third part liability (MTPL) insurance for temporary registration, or, in the case of an import from another EEA country, a 30-day certificate of insurance issued by a Swedish company. This does not apply to trailers.

#### Do you need to apply for temporary registration?

If the vehicle has a valid foreign registration and a valid foreign traffic insurance, you may drive it for no longer than one week from when the vehicle was brought into Sweden. You will require a temporary registration if you want to be able to drive the vehicle after the first week.

The only exception is when you are going to a vehicle inspection facility for the registration inspection. You are then allowed to drive your vehicle the shortest possible route to and from the inspection facility that day, but only if you have written proof that you have an appointment for a registration inspection. You also have to have a valid traffic insurance for your vehicle. You can get a written proof from the vehicle inspection facility.

#### Approval for acceptance of a previous roadworthiness test from an EU/EEA country

If your vehicle has passed a roadworthiness test in another EU-/EEA-country, you are able to include this test when the vehicle is submitted to the registration inspection in Sweden. However, this only applies to mandatory roadworthiness tests in accordance with Directive 2009/40/EC of the European Parliament and of the Council.

Write the date of the roadworthiness test on the application form and attach a copy of the vehicle inspection report to your application. Then bring the original vehicle inspection report to the vehicle inspection company at the time of the registration inspection. It is the vehicle inspection company that will make the decision whether to approve the previous roadworthiness test for acceptance in Sweden.

#### Use of the temporary registration within and outside of Sweden

In Sweden, a vehicle with a temporary registration are not allowed to be used professionally. The Swedish Transport Agency will grant either unrestricted or restricted use in connection with the temporary registration of imported vehicles.

If your vehicle is imported from a country **outside of EU/EEA**, or if it has never been permanently registered, the temporary registration will always be restricted. This means that you only are allowed to drive your vehicle the shortest possible route

- from a port, railway station, customs, workshop or similar to a place or facility where your vehicle can be kept until it is time for the registration inspection
- to and from the registration inspection.

Are you planning to use your vehicle outside of Sweden? The rules for how a vehicle with temporary registration can be used differs from country to country. Therefore, please check how the vehicle can be used in the country or countries you are planning to visit.

When you apply for a verification of origin, you should state if you intend to apply for a temporary registration. The decision of whether to assign a temporary registration for your vehicle or not, is taken after the verification of origin is approved. Your application has to have arrived at the Swedish Transport Agency no more than two months after the vehicle has been brought into Sweden.

The temporary registration is valid for three months and can be approved when the applicant, the owner of the vehicle, is permanent resident of Sweden but have been purchased abroad. The validity cannot be extended and will be cancelled upon a change of ownership.

#### When your application has been approved

When we have approved your application, we will send you the following:

- Red registration plates with white characters. They should be attached to your vehicle immediately.
- Part 1 of the registration certificate, and a decision regarding the temporary registration.

The temporary registration is valid under the condition that you have a valid Swedish traffic insurance.
