The application must be accompanied by the documents specified below.

Temporary registration – import of vehicle for temporary use in Sweden

Transportstyrelsen (the Swedish Transport Agency) can approve a temporary registration for a vehicle that has been imported into Sweden and will only be used temporarily for private use or test driving with no intent for permanent use or registration here. The temporary registration is valid for three, six or twelve months and can be approved if the **applicant, i.e., the owner, is not a permanent resident of Sweden** but is staying in the country temporarily. If the application refers to a vehicle that will be used for test-driving, the application may be made before the vehicle is brought into the country.

How to apply

The application form must be completed by the **owner**. The form on page one must be complete and the following documents attached to the application:

- **proof of Swedish third party liability insurance for temporary registration**, or when temporarily importing a vehicle purchased in another EEA country, 30 day insurance certificate issued by a Swedish insurance company (does not apply to trailers).
- **written record showing that the vehicle passed the motor vehicle inspection test (MOT test) in Sweden within the past twelve months of the application, or a corresponding foreign certificate showing that the vehicle was tested and approved in compliance with Council Directive 2009/40/EC of 6 May 2009** no longer than twelve months prior to the application, or a **certificate issued by the manufacturer**, signed by an authorised person, showing that the vehicle meets the requirements stipulated in the Council Directive.

If a period of validity is not specified at application, temporary registration is automatically twelve months.

Applying for a temporary registration is free of charge.

When the application has been approved

When temporary registration has been approved, the following documents are sent to the owner's address in Sweden:

- **Special number plates** with a registration number in white on a red background. These plates are to be mounted on the vehicle immediately.
- **A registration certificate and the approved temporary registration**. These must be kept in the vehicle during travel and presented to a police officer or vehicle inspector upon request.

If a 30-day insurance certificate is being used for the application, the vehicle will be uninsured for the remaining period of validity of the temporary registration as of day 31 after the initial date of the certificate unless the insurance is renewed through a Swedish insurance company.

If the vehicle changes owner, the temporary registration will expire immediately.

The period of validity cannot be extended. We are unable to approve a new temporary registration for a vehicle imported for **private use** earlier than twelve months after the end of the previous period of temporary registration. Although the period of validity cannot be extended in the case of a vehicle imported for the purpose of **test-driving** either, a new temporary registration can be approved directly when the previous one expires.

The special number plates are to be destroyed as soon as the temporary registration expires.

Use in Sweden and abroad

A temporarily registered vehicle may be used in normal traffic in Sweden, but not for commercial use.

If the vehicle is to be used abroad, it is advisable to check how a vehicle with a Swedish temporary registration may be used in the intended country or countries of use.
