#### Svar från EASA:

- "All items in the report are valid, i.e. they need to be corrected
  - Summary of changes
  - Use of the phrase "release or return to service".
- "In the meantime you should use the phrase "release or return to service" for component releases as detailed in "the source document, Annex 2 to the Agreement, Appendix 1, Special Conditions 1.1.1 b)iii and 2.1.1 b)iii"

## Regel

#### 145.A.50 Certification of maintenance

Regulation (EU) 2020/270

- (a) A certificate of release to service shall be issued by appropriately authorised certifying staff on behalf of the organisation when it has been verified that all maintenance ordered has been properly carried out by the organisation in accordance with the procedures specified in point 145.A.70, taking into account the availability and use of the maintenance data specified in point 145.A.45 and that there are no non-compliances which are known to endanger flight safety.
- (b) A certificate of release to service shall be issued before flight at the completion of any maintenance.



### **AMC**

#### AMC 145.A.50(b) Certification of maintenance

ED Decision 2015/029/R


The certificate of release to service should contain the following statement:

'Certifies that the work specified, except as otherwise specified, was carried out in accordance with <a href="Part-145">Part-145</a> and in respect to that work the aircraft/aircraft component is considered ready for release to service'.

Reference should also be made to the EASA Part-145 approval number.




