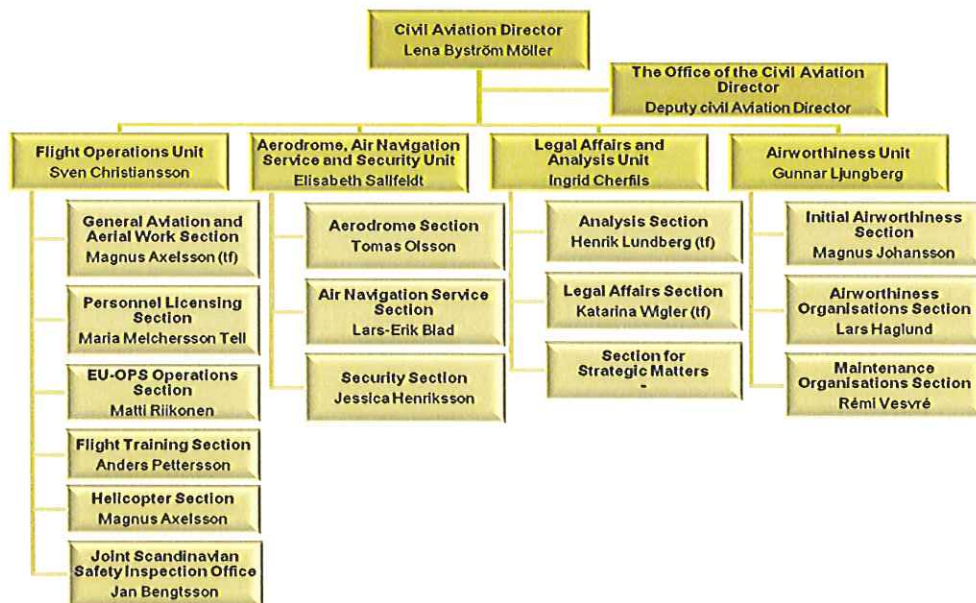


The core activities within Swedish Transport Agency are, Railway, Civil Aviation, Maritime, Traffic Registry and Road Traffic. The Swedish Transport Agency is institutionally separated from the Air Navigation Service Providers.

The transport policy overall goal is to ensure a financially efficient and long-term sustainable supply of transport for individuals and industry in the whole country. Functional goals - accessibility - the structure of the transport system, its function and use shall contribute to providing everybody with fundamental accessibility, high quality and utility, as well as adding to development of the whole country. The transport system shall be gender-equal, providing for women's and men's needs for transport. Consideration goals - safety, environment and health - the structure of the transport system, its function and use shall be adapted to prevent any deaths or serious injuries. It shall also contribute to the fulfilment of environment quality goals and improved health.

The Swedish Transport Agency has overall responsibility for civil aviation and is responsible for the authority tasks relating to air navigation services for civil and military aviation.

The Swedish Transport Agency, Civil Aviation Department organisation chart is given below.



Monitoring of tolerable levels of safety as regards to airspace blocks under Swedish Transport Agency responsibility

The Swedish Transport Agency collect, evaluate and store all information related to accidents, incidents and occurrences using the ECCAIRS database. The information is made available to the other EU Member States in accordance with (EC) No 1321/2007 by the Research, Evaluation and Analysis Department.

The Safety Oversight process concerning Air Navigation Service is organised in the Air Navigation Service Section of the Swedish Transport Agency. The safety issues identified in the safety oversight process are listed and followed up at the next inspection/audit or else the action is specified together with the date.

Compliance with applicable safety regulatory requirements by those organisation providing ATM service in Swedish Transport Agency area of responsibility

The Swedish Transport Agency provide initial and ongoing oversight to ensure compliance with applicable international and national regulatory requirements.

Programme of safety regulatory audits, including information about the audits conducted and their scope

In addition to a permanent focus on Safety Management System in ANS the ongoing safety oversight during 2009 were in focused on pure Communication, Navigation and Surveillance (CNS) providers, ATS operations and ATS personnel licensing. 19 audits were performed 2009 on the following ANSPs; LFV, Hemavan Tärnaby Airport AB, Arvika kommun, Torsby flygplats AB, Arvidsjaur flygplats AB, Vilhelmina kommun, Stockholm-Skavsta flygplats AB, AB Dalaflyget, Västerås flygplats AB, Lappland Aviation Academy.

Review of safety arguments regarding ATM Systems

Safety oversight of new systems and changes to existing ATM Systems are always accompanied by safety analysis performed by ANSPs to be reviewed by Swedish Transport Agency. A total number of 125 (major and minor) new systems and changes to existing ATM Systems was reviewed 2009.

Recognised organisations

No notified bodies have been appointed in Sweden.

Existing levels of resources in Swedish Transport Agency

Five ANS inspectors was working at the Air Navigation Service Section. The primary tasks are safety oversight however also other tasks are conducted.

Safety issues identified through the safety oversight process

No significant safety issues were identified.

Safety directives

No safety directives were issued by Swedish Transport Agency during 2009.
