The application must be accompanied by the documents specified, see the following information.

Temporary registration – export of used vehicle

Transportstyrelsen (The Swedish Transport Agency) can approve a temporary registration of a used vehicle that is to be exported from Sweden. A temporary registration is valid for one month and can be approved when the applicant, i.e. the buyer of the vehicle, does not have a Swedish address as main place of residence but has bought a used vehicle here.

However, temporary registration of the vehicle will not be approved if there is a driving ban due to unpaid taxes.

How to apply

The application must be completed by the buyer. The following documents shall be attached to the application:

- An insurance certificate for temporary registration issued in the country to which the export refers, when exporting to another EEA country and the export is completed within 30 days from purchase in Sweden. If more than 30 days have passed since purchase, or when exporting to a country outside of the EEA, use a Swedish insurance for temporary registration instead. (This does not apply to trailers.)
- A protocol of an approved vehicle inspection or roadworthiness test in Sweden valid at least one month from the date when the temporary registration is approved, if this information does not show in the road traffic registry. A vehicle inspection will not be considered valid if there will be an automatic driving ban (due to the vehicle not being tested in time) within one month after the temporary registration is granted or if the vehicle after the last inspection received a driving ban or were ordered to undergo another roadworthiness test (retest).
- The Swedish registration certificate in original version with a notification of deregistration (export), signed by the seller of the vehicle.
- The Swedish number plates. (This does not apply to unregistered vehicles.)

The last two points is the responsibility of the seller in Sweden.

Temporary registration can also be approved for unregistered used vehicles.

Applying for a temporary registration is free of charge.

When the application has been approved

When temporary registration has been approved, the following documents are sent to the applicant's address in Sweden:

- Special number plates with a new registration number in white on a red background. Mount the plates on the vehicle immediately.
- A registration certificate and the approved temporary registration. Keep these documents with you during travel and present to a police officer or vehicle inspector upon request.

If a 30-day insurance certificate is being used for the application, the vehicle will be uninsured as of day 31 and for the remaining period of validity, unless the insurance is renewed through a Swedish insurance company.

If the vehicle changes owner, the temporary registration expires immediately.

The period of validity cannot be extended. We cannot approve a new temporary registration for the vehicle before twelve months have passed since the end of a previous temporary registration period. Destroy the special number plates when the temporary registration expires.

Use in Sweden and abroad

A vehicle with temporary registration may be used in normal traffic in Sweden, but not for commercial purposes.

Rules for use of temporarily registered vehicles may differ from country to country. It is therefore advisable to check the rules in the intended country of use.
